 - o 57 pre-k classrooms are being served for ESE services
 - o Increase of 9% student population each year; ESE population grows approximately 4% each year

• Principal's Update:

- Dr. Gates reviewed:
 - 1364 students currently and growing approximately 120 students more than projected
 - An additional computer cart was purchased
 - PTO has purchased cubbies for elementary. Currently cubbies are in central receiving waiting to be put together. Look at doing a "Drill with Dads" to assemble and deliver.
 - Middle school blanket and pajamas drive was a huge success. Thank you to Natalie and Bayley (7th grade students) for putting this on.
 - Sports teams are doing great and starting to showcase some Lakeside pride. Basketball has started. A schedule has been released.
 - Access to all areas of the building

Open Agenda:

- Beth McBride asked what the qualifications are for becoming an ESE para
 - Ms. Richardson answered: It is situationally based because there are many avenues to qualify. The district does offer incentives such as higher pay and reimbursement of some exams for certain positions. Anyone interested in an ESE position is encouraged to apply.
- Celestial asked if there is a cap on students who can receive ESE services due to staffing or ratios.

 Ms. Richardson answered: No. When ratios are not met, staff is hired as needed. If staff cannot be hired, a substitute is put in place until the position can be filled. When I classroom enrollment is too high, a new classroom is opened.
